

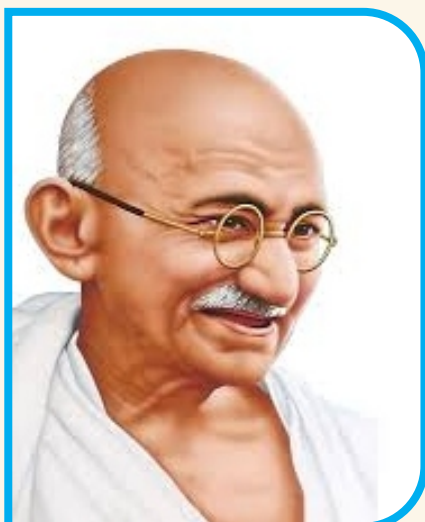

Mahatma Gandhi rightly said -



“The earth has enough resources to meet the needs of all but not to satisfy the greed of even one”

India even after seven decades of its independence has not been able to combat the evils of poverty, hunger, malnutrition, lack of basic health facilities, proper schooling for all etc. If we do some in - depth analysis of the resources India has, we will ultimately reach out to the conclusion that it indeed has ample resources to meet the needs of its citizens but due to the high economic aspirations of people in power, they adopt corrupt practices in their life, becoming greedy, and due to this lack of the spirit of selfless

service towards the society and the lack of **Good Governance**, resources released from top authorities significantly reduce in size, exactly saying to 15 %, as told by one of our previous Prime Minister, upon reaching the last beneficiary of the intended schemes. The situation leads toward unequal distribution of resources which results in rich becoming richer and poor becoming poorer.

In India there are three tiers of government, namely local Gram Panchayats / Nagar Nigam, State Governments and Central Government. At all these three levels, they have numerous social welfare schemes for the general masses but these schemes rarely achieve the outcome they have intended to achieve. The main problem lies in the lack of effective implementation and lack of Good Governance at every stage.

Good Governance mainly characterised by the extent of **transparency** and **accountability**, a system has, can help to solve the problem substantially. One of the biggest challenges which any institutionalised framework faces are developing models to increase **transparency** and **accountability** in the system. If left unchecked, it can multiply resource misuse and provide for leakages in the system leading to resource divergence.

In the contemporary context, where the government works in close collaboration with other entities such as corporations (national and multinational), academic institutions, intergovernmental organisations, etc. the promotion of effective governance has to integrate these various actors. For a country like India, it is of significant importance that collective action must be undertaken to foster the goals of **Good Governance** which has the power to fight with the large no. of challenges our country is facing.

AGAM has been started to address these issues and bring a positive change in the society by accepting all these challenges. AGAM envisioned to be the hallmark of Good Governance in India.

Our Hallmark Project (Gramodaya)

■ ■ ■ Hallmark Project - Gramodaya

The villages in India are home to 830 million people, comprising 70% of India's population. This reveals the vast human capital of India residing in villages. The importance of this resource is further strengthened by the fact that India is an agrarian economy. India's villages also house exceptional resources in terms of tangible and intangible property such as traditional knowledge, handicrafts, handlooms etc.



Rural India didn't received its due attention in the years following independence. However the beginning of this millennium has been substantial change on this front. In the past few years, the government has laid special emphasis on the development of the rural areas alongside urban development and industrial growth. The inclusion of villages in the development process will have multifold impact such as inclusive development, increase in farmer's welfare and income, support to secondary industries etc. The governmental efforts are bearing results but there exists a mismatch between the schemes and their intended outreach. The project **Gramodaya** bears in mind this fundamental concern which needs immediate attention to bridge the gap between governmental schemes and the target audience. AGAM as an organisation is involved primarily in facilitating an increase in the outreach of government schemes to the marginalised.

The project **Gramodaya** is one of the tools to foster this end. **Gramodaya** project uses a bottom-up approach, whereby the children are the Agents of Change. We have established Gram Shiksha and Suchna Kendra (GSSK) for the purpose of educating the children in particular and raising awareness among the villagers in general. The GSSKs serves as a centre of transformation assisting in providing quality education in subjects such as English, Mathematics, and Computer Science through technological intervention to necessitous children.

Each such Kendra is being assisted by a GramMitra who is the first person of contact. The GramMitra not only educate the students enrolled with the centre but also involved in administrative tasks such as assessing the needs of the Kendra , identifying the needs of students, celebrating special days related to Environment, Governance, Independence Day etc., organising events (where and if necessary) for the parents of the students etc.



One of the crucial elements of the Gramoday project is technological intervention in the field of Good Governance. This is being used foremostly in maintaining **transparency** in the structure and functioning of the Gramoday project followed by imparting digital literacy to the students and other interested stakeholders at our Computer Center.

Further, we organise awareness camps on a regular basis not only to make them aware of their citizenry rights but also to inform them about social welfare schemes sponsored by State and Central Government.



We also organise health camps in villages on a regular basis with an aim not just to provide health services but to create an environment where the whole community gets sensitized about health issues.

Currently, Gramodaya project is being implemented in three villages namely Babhniyawan and Darjipurwan in Bahraich district and Bijauli in Meerut district in UP and we are persistently looking to serve other villages across India under the project.

Gram Shiksha and Suchana Kendra(GSSKs) -

1. Babhniyawan, Bahraich

It is situated 40 kms away from Bahraich, which is both district and sub-district headquarter of Babhniyawan village. The transport connectivity up to the village is not good. The government bus facility is available only up to Payagpur which is about 16 km away from the village. From there people have to have their own vehicle to reach the village. The other way one has to reach to Bilaruwa More through local tempo/taxi and from there the village is about 3 kms away that has to be covered by bicycle/own vehicles/on foot.

According to 2011 census of India, Babhniyawan's population is 3450 out of which 1893 people are illiterate which amounts for 54% - the darkest part of the village. Most of the villagers are farmers and totally dependent on their farm products for daily livelihoods.



In the village there is school facility available only up to class 8 (that too only one primary govt. school till class 5 and one govt. high school till class 8). If one wants to study beyond he/she has to travel at least 15kms (to and fro) to go to secondary school.



We are running our Gram Shiksha and Suchna Kendra (GSSK) in this village since the inception of AGAM. Till now we are able to change the level of quality education being provided to children through our modern Shiksha Kendra, the learning center, having high speed internet facilities, a projector, computer etc. to make them on par with the public school going children of cities and towns.

Gram Shiksha and Suchana Kendra(GSSKs) -

We have impacted the lives of almost 2000 people living in the village through regular counselling and awareness camps regarding their citizenry rights, laws against corruption, raising awareness amongst them regarding various redressal mechanisms available both online and offline etc.

Our major activities in the village includes -

- (i) Providing Quality Education to underprivileged children through technological interventions.
- (ii) Organising Health Camps & Eye Check-Up Camps on a regular basis.
- (iii) Organising Rallies and Social Awareness Camps raising awareness about civic rights, laws against corruption, Right to Information (RTI) Act, various redressal mechanisms available both online and offline etc.
- (iv) Providing free legal assistance to people fighting against corruption.



2. Darjipurwan, Bahraich

Darjipurwa, is a village about one and a half kms away from Babhniyawar. The conditions are almost similar. The literacy rate is below the national average. The majority of the population are Muslims and are dependent on agriculture. A major percentage of male population migrate to Saudi Arabia for livelihood purposes as labourer, helper etc. The girls are married at an early age as conventionally they are considered to do household works only and education is not considered essential for them.

In the village rarely any boy of age more than 15 has continued his studies mostly because they help their family by earning some money by doing some job in some nearby city. In the village there is only one primary government school and one urdu school. Some of the little faces who attend urdu school don't know how to write their names in hindi/english, they lag behind others who goes to primary school in terms of modern education.

The situation is worse for girls. Girls left study even at an early age mainly because of her marriage or traditional reason for not giving much importance to education for girls.



In this village our GSSK is running for more than 6 months now (started in Oct. 2017). Here, almost 20-30 students come to our centre regularly. Some of the interested higher class students come to Babhniyawar to learn computer.

We are doing our best to provide them good quality education and modern computer education to cope up with the modern public school going children in the cities.

Gram Shiksha and Suchana Kendra(GSSKs) -

3. Bijauli, Meerut

Bijauli is a Village in Kharkhoda Block in Meerut District of Uttar Pradesh, India. It is located 16 KM towards South from District head quarters Meerut and 451 KM from State capital Lucknow.

According to 2011 census Bijauli village total population is 6062 in which female Population is 47.0%. Village literacy rate is 67.7%. Male literacy stands at 87.14 % while female literacy rate is 69.08 %.



This Gram Shiksha and Suchna Kendra (GSSK) has been opened in July this year. There are almost 30 students who are attending the evening classes on a regular basis. We have recruited well-educated local teachers to provide the best quality education possible to the students coming to our centre.

The enthusiasm of students are remarkable there. As quality education is very rare in the village, students come at our centre and provided with high quality Maths, English and Value Education along with the computer education. The computer centre also serves as a Suchna Kendra for general people of the village for any type of information related to any government schemes, civil rights etc.

Health Camp at Babhniyawan village in Bahraich (April, 2017)



Apart from other regular activities, this year started with a Health Camp being organised twice within a week on third and fourth Sunday in April at Babhniyawan village in UP. Villagers from nearby villages came for their regular Check-Up, many old age people, women and children attended the camp and given prescription along with some immediately required medicines.

Started a new GSSK in Bijauli village in Meerut (July, 2017)

Bijauli is a Village in Kharkhoda Block in Meerut District of Uttar Pradesh, India. It is located 16 KM towards South from District head quarters Meerut and 451 KM from State capital Lucknow.

According to 2011 census Bijoli village total population is 6062 and female Population is 47.0%. Village literacy rate is 67.7%. Male literacy stands at 87.14 % while female literacy rate is 69.08 %.

We have started a new Gram Shiksha and Suchna Kendra (GSSK) in July this year in the village Bijauli. The response of students and the villagers were remarkable there. Students in large numbers attend our Shiksha Kendra daily and try to learn as much as they can.

Parents and villagers regularly visit our Suchna Kendra for different types of information like social welfare schemes, their civic rights etc. and also interact with our local volunteers to know about their children's progress in study.

We are very much hopeful to have some fruitful long term positive change in the village
