Any country in the world can't develop without taking into account the aspects of **Good Governance**. Normally, the resources available to us are capable of fulfilling our needs but the lack of proper management of resources, lack of an efficient system which can wisely put these resources in use and most importantly the lack of transparency and **Good Governance** in the system leads to an ad hoc type situations and the economy of the state collapses which severely affect the common citizens of the country.

In India there have been numerous instances of resources divergence and misuse of resources due to the absence of an efficient system. Being a developing country the relevance of **Good Governance** and transparency & accountability of the system becomes more relevant to put India in the category of Developed Nations in near future.

Since, Independence India has been plagued with the evils of corruption. In India there are three tiers of government, namely local Gram Panchayats / Nagar Nigam, State Governments and Central Government. We have worked especially to create awareness about civil rights and tools for the communities that havn't had the opportunity to avail these rights.

We are working in the areas of education, health, environment, rural development, law and justice, anti-corruption & transparency etc. AGAM has taken a lead in helping the students of the village with their education. In its two centres we run evening classes for students from pre-primary to secondary level. The feedback that we have received on this programme have been highly encouraging. We periodically conducts medical camps to provide the village residents with basic health evaluations. The **GSSK** being equipped with computers and the internet services makes people to learn and access the information very easy.

In the coming year, AGAM looks forward to continue to sustain these activities in the state. We intend to increase our services and their outreach in different parts of the country. The education platform is also intended to reach out to more students in numbers. Our goal is to provide legal guidance and platforms for in need residents of remote villages and make them available RTIs and PILs in greater public interest.

AGAM is also intending to increase its engagement with communities and create awareness about its programme and mission. We are determined to make AGAM a success and carry forward its presence in remote areas throughout India.

Our Hallmark Project (Gramodaya)

■ ■ ■ Small Efforts with Big Impact - Our Hallmark Project: Gramodaya

The villages in India are home to 830 million people, comprising 70% of India's population. This reveals the vast human capital of India residing in villages. The importance of this resource is further strengthened by the fact that India is an agrarian economy. India's villages also house exceptional resources in terms of tangible and intangible property such as traditional knowledge, handicrafts, handlooms etc.



Rural India didn't received its due attention in the years following independence. However the beginning of this millennium has been substantial change on this front. In the past few years, the government has laid special emphasis on the development of the rural areas alongside urban development and industrial growth. The inclusion of villages in the development process will have multifold impact such as inclusive development, increase in farmer's welfare and income, support to secondary industries etc. The governmental efforts are bearing results but there exists a mismatch between the schemes and their intended outreach. The project **Gramodaya** bears in mind this fundamental concern which needs immediate attention to bridge the gap between governmental schemes and the target audience. AGAM as an organisation is involved primarily in facilitating an increase in the outreach of government schemes to the marginalised.

The project **Gramodaya** is one of the tools to foster this end. **Gramodaya** project uses a bottom-up approach, whereby the children are the agents of change. We have established **Gram Shiksha and Suchna Kendra (GSSK)** for the purpose of educating the children. The **GSSKs** serves as a centre of transformation assisting in providing quality education in subjects such as English, Mathematics, and Computer Science through technological intervention to necessitous children.

Each such Kendra is being assisted by a **GramMitra** who is the first person of contact. The **GramMitra** not only educate the students enrolled with the centre but also involved in administrative tasks such as assessing the needs of the Kendra, identifying the needs of students, celebrating special days related to Environment, Governance, Independence Day etc., organising events (where and if necessary) for the parents of the students etc.

One of the crucial elements of the **Gramodaya** project is technological intervention in the field of **Good Governance**. This is being used foremostly in maintaining transparency in the structure and functioning of the **Gramodaya** project followed by imparting digital literacy to the students and other interested stakeholders at our **Computer Center**.

Further, we organise awareness camps on a regular basis not only to make them aware of their citizenry rights but also to inform them about social welfare schemes sponsored by State and Central Government.

We also organise health camps in villages on a regular basis with an aim not just to provide health services but to create an environment where the whole community gets sensitized about health issues.



Recently, we also took a few other initiatives one of them being to educate the local farmers about organic farming and its benefits which has gained popularity among the community, the other being women empowerment program stressing upon training on operating sewing machines, embroidery, arts, and designing skills as well as tailoring that can assist in their livelihood.

Currently, Gramodaya project is being implemented in four villages namely **Babhniyawan, Darjipurwan, Tilkhawan** in Bahraich district and **Bijauli** in Meerut district of Uttar Pradesh and we are persistently looking to serve other villages across India under the project.

Gram Shiksha and Suchana Kendra(GSSKs) -

1. Babhniyawan, Bahraich

It is situated 40 kms away from Bahraich, which is both district and sub District headquarter of Babhniyawan village. The transport connectivity up to the village is not good. The government bus facility is available only up to Payagpur which is about 16 km away from the village. From there people have to have their own vehicle to reach the village. The other way one has to reach to Bilaruwa More through local tempo/taxi and from there the village is about 3 kms away that has to be covered by bicycle/own vehicles/on foot.

According to 2011 census of India, Babhniyawan's population is 3450 out of which 1893 people are illiterate which amounts for 54% - the darkest part of the village. Most of the villagers are farmers and totally dependent on their farm products for daily livelihoods.

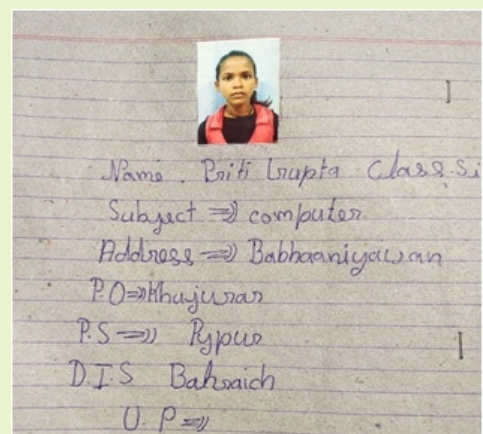
In the village there is school facility available only up to class 8 (that too Only one primary govt. school till class 5 and one govt. high school till class 8). If one wants to study beyond he/she has to travel at least 15 kms (to and fro) to go to secondary school.



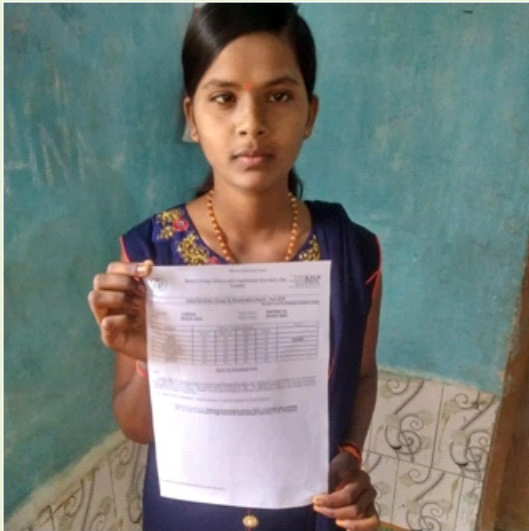
Our Impact -

AGAM started its centre in the village almost two years ago and encouraged students especially girls to step up, take a bicycle and go to secondary schools out of the village to complete her education as the general norms for girls were to leave study after class 8.

After the continuous hard work of our volunteers and continued support from the villagers, this year probably the first batch of girls of class 10 has passed out from the village.

Pooja Devi is such a student of the regular batch at our centre and passed out the class 10th from UP board this year. Although scored less marks in some subjects she is a laborious student and really worked hard to get this result. She travelled 15 kms daily (to and fro) on bicycle to achieve this.

Till now we have impacted the lives of more than 400 students in the village with more than half of them being girls through quality education focused on Mathematics, English, Computer Science and Value Education.

Through regular camps and rallies on different occasions like Anti-corruption day, RTI week, Good governance day etc. we impacted the lives of thousands of people living in villages. They are now well aware about their civic rights, different social welfare schemes etc. They are well versed with the system and don't need anyone's help in taking benefit of schemes or realising their citizenry rights now. It has impacted their lives in a very positive way.

Gram Shiksha and Suchana Kendra(GSSKs) -

2. Darjipurwan, Bahraich

Darjipurwan, is a village about one and a half kms from Babhniyawar. The conditions are almost similar. The literacy is below the national average. The majority of the population are Muslims and are dependent on agriculture. A major percentage of male population migrate to Saudi Arabia for livelihood as labourer, helper etc. The girls are married at an early age as conventionally they are considered to do household works only and education is not considered essential for them.

In the village rarely any boy of age more than 15 has continued his studies mostly because they help their family by earning some money by doing some job in some near about city. In the village there is only one primary government school and one Urdu School. Some of the little faces who attend Urdu school don't know how to write their names in hindi/english, they lag behind others who goes to primary school in terms of modern education.

The situation is worse for girls. Girls left study even at an early age mainly because of her marriage or traditional reason of not giving much importance to education for girls.

3. Tilkhawan, Bahraich

Tilkhawan is the adjacent village, some 3 kms away from the village Darjipurwan. It also falls in Bahraich district in UP. Similar situation as that of Babhniyawar exists here. Primary school in Tilkhawan village is providing students the education till class 5 and the high school is shared with the Babhniyawar village providing students, education till class 8. After class 8 students has to travel 10 kms approx. (to and fro) to go to higher secondary school.



We have opened our centre there in September this year. The enthusiasm of students are remarkable there. As quality education is very rare in the village, students come at our centre and provided with high quality Maths, English and Value Education along with the computer education. The computer centre also serves as a Suchna Kendra for general people of the village for any type of information related to any government schemes.

3. Bijauli, Meerut

Bijauli is a Village in Kharkhoda Block in Meerut District of Uttar Pradesh, India. It is located 16 KM towards South from District headquarter Meerut and 451 KM from State capital Lucknow.

According to 2011 census Bijauli village total population is 6062 in which female Population is 47.0%. Village literacy rate is 67.7%. Male literacy stands at 87.14 % while female literacy rate is 69.08 %.

This Gram Shiksha and Suchna Kendra (GSSK) has been here opened last year in July 2017. There are almost 30 students who are attending the evening classes on a regular basis. We have recruited well-educated local teachers to provide the best quality education possible to the students coming to our centre.



The enthusiasm of students are remarkable there. As quality education is very rare in the village, students come at our centre and are provided with high quality Maths, English and Value Education classes along with the computer education. The computer centre also serves as a **Suchna Kendra** for general people of the village for any type of information related to any government schemes, civil rights etc.

A new GSSK has been opened in Tilkhawan village (May, 2018)



In May 2018 we started our new GSSK in Tilkhawan Village in Bahraich District, Uttar Pradesh, a small effort towards improving the education system in rural India. Currently, we are offering daily two hours coaching to the children with a focus on Maths, English, Computer Science and Value Education.

World Environment Day Painting Competition (June, 2018)

We organised Painting and Easy writing Competitions at all the Shiksha Kendra namely Babhniyawar, Darjipurwar and Tilkhawan Village of Bahraich District in Uttar Pradesh on the occasion of world environment day with a theme - "Need to protect the environment".

More than 150 + students participated in the competition. The aim of such regular drawing and easy competition is to engage children in a creative exercise to identify their hopes and dreams of the future. It allows complete self-expression and supports their creativity and innovative ideas expressed through art.

Independence Day Celebration (August, 2018)



On the occasion of Independence Day, the Volunteers and Students of AGAM organized a rally to highlight the importance of education and the evils of corruption covering three villages: Babhniyawar, Darjipurwar and Tilkhawan of Bahraich District. AGAM is running "Gram Shiksha and Suchna Kendra" in these villages.

Opening of a new Computer Centre in Tilkhawan village (September, 2018)

We have launched our second computer centre at Tilkhawan village, District Bahraich. The students can use this facility for e-learning and also access online educational material, this facility is also open to villagers who can use online facility to know more about government schemes and also file online complaints on various grievance redressal portals of state and central governments, including filling of online RTI application.

Safe and clean environment is one of the prerequisites for the holistic development of the society, keeping the mission of AGAM at forefront the students and volunteers of centre carried out drain cleaning exercise in the Babhniyawar village. We are hopeful that the efforts of young volunteers will also motivate senior and other members of the community and they will join the mission of making our village clean and sustainable.

RTI week celebration (10th to 16th Oct. 2018)

Right to Information (RTI) is the most empowering tool in the hands of the common citizen of India, post-independence. On the eve of the RTI day AGAM has organized series of awareness meeting on RTI in and around our 3 centres located in Bahraich district. We have conducted awareness sessions on RTI including special sessions for students of the centre so that our future voters are made aware of the importance of good governance and accountability. Challenges linked with demand and accountability are more in rural India than what exist in cities, we are very much hopeful that these awareness sessions and meetings will be helpful in addressing those challenges.



Better politics for Development Network - A concept note prepared (Nov. 2018)

We have conceptualised an Initiative "Better Politics for Development Network" under the banner of AGAM: An Initiative for Good Governance aimed at bridging the gap between policy making and developmental initiative by engaging more people in the initiative.

Better Politics for Development Network

Connecting people and political leaders through development practice

A new voluntary network to bring positive change in political processes and public policies that benefit the lives of the people who are less advantaged through better understanding and integration of good development practice

The network will provide a regular forum for interaction between development practitioners and political leaders, especially focusing on youth. This forum will help overcome the current deficit of limited and weak interaction between people in development and people in politics.

Who can be the members of the network?

We are initiating a new voluntary network of practitioners who are active or want to participate in improving citizen participation in public policy making and its implementation in India, from the perspective of the less advantaged groups. An initial list of issues, given below would be taken up for public action. Members can propose new issues.

Why a new network to promote better interaction between developmental practice and political process?

In India, too often, public policy is designed based on limited public inputs and knowledge of local and international good practice. Often the policies seem well designed, but they fail during implementation. Implementation failure is a failure of policy design. There is limited assessment of why policies fail. People's feedback mechanisms are often missing. Sometimes policy making revolves around the interests of the powerful groups, leaving marginalised groups to bear adverse impacts; sometimes the public policy process excludes the marginalised sections and sometimes the policy making is just wishful thinking with budgets attached to them.

The process of policy design and implementation needs significant overhaul. It needs to respond to the development needs of a vast, diverse and increasingly aspirational society, taking into account rapid changes in technology, climate change, corporate social responsibility, entrenched social norms, new laws and values of privacy and ethics and the search for appropriate institutional design for delivering policies suited to the context. Public policy making process need to be integrated to local and global realities. Policy makers and practitioners need to connect better with people, especially those who are marginalised and vulnerable. Artificial boundaries between sectors and disciplines need to be blurred for achieving better development outcomes.

There are challenges but also opportunities. Youth, everywhere, are driving many fundamental changes. Technology is changing and delivering impact at frenetic pace. Regulations are falling behind. People are finding new ways to build collective action. Political leaders have to listen to and respond to many voices.

This network will bring new energy and new ways of engagement with the policy and political process. Through this network we want to make policy making more i) *rigorous* - that takes into account social, environmental and governance costs and benefits ii) *inclusive* - that responds to the needs of the marginalised and vulnerable groups and iii) *appropriate* - based on good local and global practice.

What are the next steps?

To start operations we are looking at signing up at least 100 members who agree to support this network. We are looking to hire a small place, which becomes a space to meet, network, discuss ideas, build action plans and socialise on a regular basis. We will also create technology enabled virtual space for enriching interactions.

What activities the network/forum can carry out?

Initial ideas are:

1. Regular interaction between young political leaders and developmental practitioners on good development practice
2. Structured interaction between political leaders and common interest groups/citizens on development issues for better feedback mechanisms across the country.
3. Orientation of young political leaders on social issues, social accountability assessments and communication with marginalised groups.
4. Training/orientation of political leaders on policy design and implementation
5. Orientation of developmental practitioners on political processes and public policy
6. Organisation of self-improvement sessions by the members for other members
7. Mentorship by senior members to support younger members.

What do we need from you?

We need you to sign up as a member and pay a membership fee @INR 1000 per month. This can be paid on a quarterly basis (INR 3000 every quarter). A foundational deposit of INR 5000 to build the network. A commitment to engage, shape the network and take forward key issues on a regular basis.

The network would be launched in December in Delhi with regional contacts.

■■■ Be a Local Champion Program




