Foreword

There is a great and very important Sloka of Bhagavad Gita in Sanskrit reads as

**yatra yogeshvarah krishno yatra partho dhanur-dharah
tatra shrir vijayo bhutir nitir matir mama**

which means -

"To move on the ladder of success with morality, opulence, victory and empowerment (MOVE), we need to believe that Lord Krishna and Arjun are with us".

In the 1992 report entitled "Governance and Development", the World Bank set out its definition of **Good Governance**. It defined **Good Governance** as "the manner in which power is exercised in the management of a country's economic and social resources for development".

Good Governance has 8 major characteristics. It is participatory, consensus-oriented, accountable, transparent, responsive, effective and efficient, equitable and inclusive and follows the rule of law. It assures that corruption is minimized, the views of minorities are taken into account and that the voices of the most vulnerable in society are heard in decision-making. It is also responsive to the present and future needs of society.

People should be able to voice their own opinions through legitimate immediate organizations or representatives. This includes men and women, vulnerable sections of society, backward classes, minorities, etc. Participation also implies freedom of association and expression

AGAM has been started to address these issues and bring a positive change in the society by accepting all these challenges. AGAM envisioned to be the hallmark of **Good Governance** in India.

Small Efforts with Big Impact – Our Hallmark Project:

The villages in India are home to 830 million people, comprising 70% of India's population. This reveals the vast human capital of India residing in villages. The importance of this resource is further strengthened by the fact that India is an agrarian economy. India's villages also house exceptional resources in terms of tangible and intangible property such as traditional knowledge, handicrafts, handlooms etc.



Rural India didn't receive its due attention in the years following independence. However the beginning of this millennium has seen substantial change on this front. In the past few years, the government has laid special emphasis on the development of the rural areas alongside urban development and industrial growth. The inclusion of villages in the development process will have multifold impact such as inclusive development, increase in farmer's welfare and income, support to secondary industries etc. The governmental efforts are bearing results but there exists a mismatch between the schemes and their intended outreach. The project **Gramodaya** bears in mind this fundamental concern which needs immediate attention to bridge the gap between governmental schemes and the

target audience. AGAM as an organisation is involved primarily in facilitating an increase in the outreach of government schemes to the marginalised.

Hallmark Project – Gramodaya



The project **Gramodaya** is one of the tools to foster this end. **The Gramodaya** project uses a bottom-up approach, whereby the children are the agents of change. We have established **Gram Shiksha and Suchana Kendra (GSSK)** for the purpose of educating the children. The **GSSKs** serves as a centre of transformation assisting in providing quality education in subjects such as English, Mathematics, and Computer Science through technological intervention to necessary children.

Each such *Kendra* is being assisted by a **Gram Mitra** who is the first person of contact. The **Gram Mitra** not only educate the students enrolled with the centre but also involved in administrative tasks such as assessing the needs of the *Kendra* , identifying the needs of students, celebrating special days related to Environment, Governance, Independence Day etc., organising events (where and if necessary) for the parents of the students etc.



One of the crucial elements of the **Gramodaya** project is technological intervention in the field of **Good Governance**. This is being used foremostly in maintaining transparency in the structure and functioning of the **Gramodaya** project followed by imparting digital literacy to the students and other interested stakeholders at our **Computer Center**.

Hallmark Project – Gramodaya

Further, we organise awareness camps on a regular basis not only to make them aware of their citizenry rights but also to inform them about social welfare schemes sponsored by the State and Central Government.

We also organise health camps in villages on a regular basis with an aim not just to provide health services but to create an environment where the whole community gets sensitized about health issues.



Recently, we also took a few other initiatives one of them being to educate the local farmers about organic farming and its benefits which has gained popularity among the community, the other being women empowerment program stressing upon training on operating sewing machines, embroidery, arts, and designing skills as well as tailoring that can assist in their livelihood.

Currently, **Gramodaya** project is being implemented in three villages namely *Babhniyawan*, *Darjipurwan*, in Bahraich district and *Keshwapur Pajawa* in Shravasti district of Uttar Pradesh and we are persistently looking to serve other villages across India under the project.

Gram Shiksha and Suchana Kendra (GSSKs) -

1.) Babhniyawan, Bahraich

It is situated 40 kms away from **Bahraich**, which is both district and sub district headquarters of **Babhniyawan** village. The transport connectivity up to the village is not good. The government bus facility is available only up to **Payagpur** which is about 16 km away from the village. From there people have to have their own vehicle to reach the village. The other way one has to reach Bilaruwa **More** through local tempo/taxi and from there the village is about 3 kms away that has to be covered by bicycle/own vehicles/on foot.

According to the 2011 census of India, Babhniyawan's population is 3450 out of which 1893 people are illiterate which amounts for 54% - the darkest part of the village. Most of the villagers are farmers and totally dependent on their farm products for daily livelihoods.

In the village there is a school facility available only up to class 8 (that too only one primary govt. school till class 5 and one govt. high school till class 8). If one wants to study beyond he/she has to travel at least 15 kms (to and fro) to go to secondary school.

2.) Darjipurwan, Bahraich

Darjipurwan, is a village about one and a half kms from Babhniyawar. The conditions are almost similar. The literacy is below the national average. The majority of the population are Muslims and are dependent on agriculture. A major percentage of male population migrate to Saudi Arabia for livelihood as labourer, helper etc. The girls are married at an early age as conventionally they are considered to do household works only and education is not considered essential for them. In the village rarely any boy of age more than 15 has continued his studies mostly because they help their family by earning some money by doing some job in some near about city. In the village there is only one primary government school and one Urdu School. Some of the little faces who attend Urdu school don't know how to write their names in hindi/english, they lag behind others who goes to primary school in terms of modern education. The situation is worse for girls. Girls left study even at an early age mainly because of her marriage or traditional reason of not giving much importance to education for girls.



Gram Shiksha and Suchana Kendra (GSSKs) -

Our Impact -

We opened our Gram Shiksha and Suchna Kendra (GSSK) about two years ago in the village. By our continuous counselling of parents and villagers in Parent-Teacher Meeting people are becoming more aware about the importance of modern education in current era. They are now eager to send their ward to our Kendra as well as to secondary schools. Some of the students even started preparing for competitive examinations like Navodaya,NTSE etc. This year one of our students,Ashfaq, got 84 % in his final term exam. He is a new addition to our batch of students preparing for Navodaya entrance exam.

3.) Keshwapur Pajawa, Shravasti

Keshwapur Pajawa village is located in Ikauna Tehsil of Shravasti district in Uttar Pradesh, India. It is situated 33 km away from sub-district headquarter Ikauna and 25 away from district headquarter Bhinga. Keshwapur Pajawa village is also a gram panchayat. The total geographical area of the village is 450.66 hectares.

Keshwapur Pajawa has a total population of 2,501 people. There are about 425 houses in Keshwapur Pajawa village. Bahraich is the nearest town to Keshwapur Pajawa which is approximately 22 km away.

In the month of October 2019 when we were organising “Cluster Gram Sansad” in collaboration with “Teesari Sarkar Abhiyan”, one of friends of our Centre Coordinator at Bahraich approached us and showed interest in organising the

same in his village and thereafter we opened our Gram Shiksha and Suchana Kendra there.

Till March 2020, when the nationwide lockdown was announced the centre ran for almost 5 months and there has been a good response both from villagers and the students studying there.

A visit of our Project Coordinator from Delhi Office to Villages
“Babhniyawar”, “Tilkhawan” & “Darjipurwan” in UP (April 2019)



April 2019 Our Project Coordinator from Delhi office, Shri Pramod Kumar visited centre 1 & 2 of Bahraich. He stayed in the village for the next 6 days. Training of volunteers, assessment of present intervention with kids and adults of the village including those who live in nearby villages as well was the key agenda item of this visit.

He interacted with the “Gram Mitra” Shri Sandeep Mishra, Shri Neeraj Kumar, Shri Anurag Mishra and other local volunteers working on the ground level, students studying at our center, inquired about their progress report, interacted with students who left center (Shiksha Kendra). The Sewing Machine Center is home to no. of girls who left their study at an early age. He interacted with the senior girls and inspired them to utilize the time at Sewing Machine Center and at least learn how to read and write. The most exciting day for students at our center was Saturday as students got a chance to see educational videos on the projector. The Computer Center has a projector and high speed internet connection providing digital education to all students.

Shri Pramod Kumar also interacted with villagers to know about their domestic products that can be produced at mass level giving them employment as well as the respect they lost for their indigenous “technical” knowledge they process. We were very much hopeful to proceed and get succeeded in this direction.

At our AGAM Sewing Machine Center at Babhniyawan village in Bahraich district in UP (April 2019)

Girls have been given new clothes for the very first time since the starting of the classes. Till now they have just practiced over newspapers and learnt to stitch basic things from those papers.

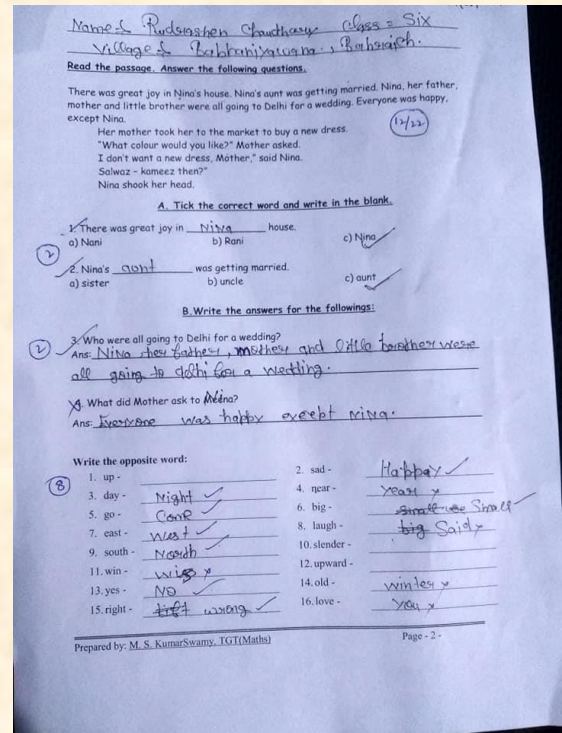
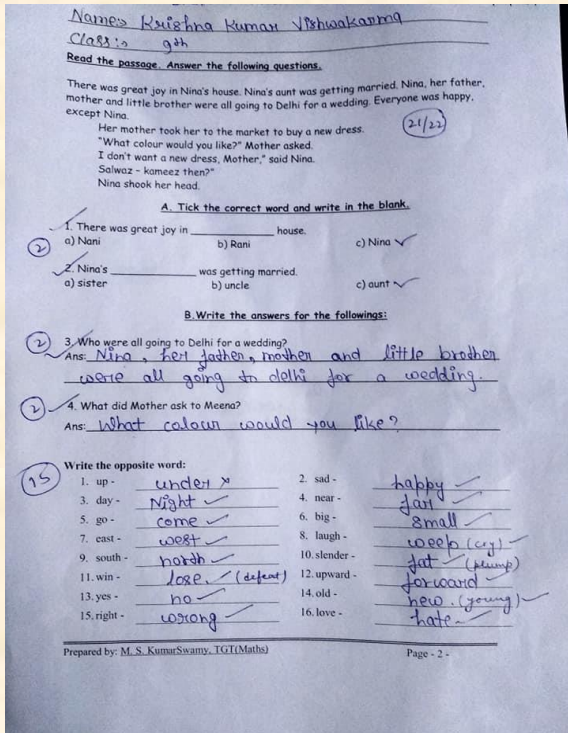
Now one step further in their learning process, they have started practising and stitching basic things of clothes. In fact, they have made a bag – jhola – as they call it, from the white cloth given!!!

A preliminary English proficiency test has been conducted to test students’ efficiency in English. The test includes a total of 14 students ranging from class 3 to class 9.

Further, according to their performance in the test three groups will be formed and they will be provided with special English classes according to their present efficiency and skills.



World Environment Day Celebration (June 2019)

On the occasion of World Environment Day, we have organised an Essay Writing and Painting Competition among the children at our Gram Shiksha Kendra at Bahniyawana village in Bahraich district in UP.

Children have been informed about the importance of this day, major challenges our earth is facing and most importantly about this year's theme "Air Pollution".



Training for Organic Farming (June 2019)

In the village Babhniyawar in Bahraich district in UP, where we run our Gram Shiksha and Suchana Kendra (GSSK), farmers have been given an initial training and exposure to Organic Farming, it's benefits both for themselves and the nature, and how people earning lakhs of rupees have left their job to make farming a profitable business with the use of pure organic things avoiding chemicals and pesticides.



Our Project Coordinator Pramod Kumar visited door to door to meet with local farmers, discussed with them the varied aspects of organic farming, tried to know their point of view about the same and had a great interaction session with all the local farmers.

Health Camp Organized (June 2019)

A Health Camp was organised in the village Babhniyawar at our Gram Shiksha and Suchana Kendra (GSSK). People including women, old age people and children from nearby vilkages came for their regular check up including some people who came for consultation regarding some serious diseases like kidney stones, TB etc.



Organized Outdoor Games (August 2019)

In this modern age of mobile phones & tabs children are getting away from outdoor games. Engaging children in outdoor games not only keeps them physically fit, it also creates a spirit of togetherness, fun and adventure.



Independence Day Celebration (August 2019)

Independence Day was celebrated at our AGAM Gram Shiksha and Suchana Kendra (GSSK) with great pride and valour at Babhniyawan village in Bahraich district in UP.

Students have taken part in Social Awareness Rally with social messages of making our country corruption free, making less use of plastics, issues concerning climate change, messages of unity in diversity of our great country etc. and making each and every people they meet to have a Nation First attitude.



Online Awareness among Students (August 2019)

Dissemination of Information in this modern age has become easy through the use of technology and the internet. Developing understanding among the children about different social welfare schemes is a key factor that can increase the outreach of such schemes in remote villages. Children are much better Agents of Change for society, they encourage everyone to get involved.
